ADVISORY

They are to closely coordinate with the District Administration & Health centres within their jurisdiction to ensure compliance of all precautionary measures to be taken in respect of COVID -19.
- All tourists are requested to avoid crowded places and public gatherings and adopt strategies for social isolation.
